ORDINANCE NO. 393

AN ORDINANCE ADOPTING A NEW BUILDING CODE; REPEALING ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; AND DECLARING AN EMERGENCY

An ordinance regulating the erection, construction, enlargement, alteration, repair, moving, removal, conversion, demolition, occupancy, equipment, use, height, area and maintenance of buildings or structures in the City of Beaverton; providing for the issuance of permits and collection of fees therefor; ~~declaring~~ and establishing Fire Districts; providing penalties for the violation thereof, and repealing all ordinances or parts of ordinances in conflict therewith.

THE CITY OF BEAVERTON DOES ORDAIN AS FOLLOWS:

Section 1. That the Pacific Coast Building Officials Conference Building Code as heretofore compiled, 1952 Edition, as amended by the 1955 Edition be and is hereby adopted and established as the building code for the City of Beaverton and said code is hereby made a part of this ordinance as if fully set out herein.

Section 2. That the City Superintendent shall serve in the capacity of Building Official which position is provided for in Chapter 2 of said uniform building code.


Section 3. That all ordinances or parts of ordinances pertaining to building codes heretofore enacted and in conflict herewith are hereby repealed.

Section 4. WHEREAS, there is a large number of buildings being constructed and to be constructed in the City of Beaverton, and in order to facilitate proper construction and adequate supervision of said construction within the city it is necessary that a uniform building code be adopted, and it is necessary for the peace, welfare and safety of the citizens of the City of Beaverton that said code be adopted immediately, an emergency is hereby declared to exist and this ordinance shall become effective upon its passage by the City Council and upon approval by the Mayor.
