AN ORDINANCE RELATING TO THE BUILDING CODE AMENDING BEAVERTON CODE SECTION 8.02.015 (C)

WHEREAS, the current Beaverton Code Section 8.02.015(C) does not have standards for construction materials, methods, and practices for rainwater harvesting systems; and

WHEREAS, the State Plumbing Code contains Appendix M Rainwater Harvesting Systems that can be adopted by the City as necessary to provide standards for construction materials, methods, and practices for rainwater harvesting systems; therefore,

THE CITY OF BEAVERTON ORDAINS AS FOLLOWS:

Section 1. BC 8.02.015(C) is amended to read as follows:

8.02.015 <u>State Codes</u>. The following State Specialty Codes are adopted as part of the Beaverton Code except as otherwise provided in this ordinance:
